Dear Mr. Farquhar and Mr. Bean,

Congratulations on your recent appointments to the Department of the Interior (DOI), and thank you for your part in the decisions to withdraw the Western Oregon Plan Revision (WOPR) and rework the northern spotted owl recovery plan and critical habitat re-designation. Our organizations work extensively in western Oregon to protect wildlands, waterways and at-risk species. Our tens of thousands of members, supporters, and volunteers truly love Oregon's wild places and cherish the opportunity to experience public lands in their natural, awe-inspiring state. We also live and work in the communities in western Oregon surrounded by BLM forests. Much of our work consists of monitoring projects on Bureau of Land Management (BLM) lands, including logging, thinning and fuels reduction activities.

The withdrawal of the misguided WOPR is a great step toward protecting mature and old-growth forests on BLM lands. We understand the desire of the DOI to move forward with ecologically and socially sound management policies that would have the BLM working productively to restore forests and generate employment in the woods. We think there are real opportunities to move a progressive agenda of forest restoration that would meet the goals of protecting these BLM forests while also producing a certain amount of timber and biomass from restoration-based thinning projects.

However, there are immediate threats to these unique ecosystems and the imperiled species that live in them. WOPR's withdrawl does not affect over 13,000 acres of mature and old growth timber sales that are currently planned on BLM land in southwest Oregon. These timber sales, located on the Roseburg and Medford BLM, were planned years ago under the Northwest Forest Plan and are only awaiting biological opinions from the U.S. Fish and Wildlife Service (USFWS). Many of the sales were part of previous consultations that were successfully stopped through litigation. They represent the "worst-of-the-worst" in terms of impacts to older forest habitat in the region. According to the Medford BLM biological assessment, 4,832 of the acres are "structurally complex" and fail to comply with Recovery Action 32 of the 2008 Recovery Plan. We have expressed repeated concern to USFWS in Oregon about the consultations, and encourage USFWS not to issue biological opinions to Roseburg and Medford BLM and explore buy-back options where necessary.

Amidst the controversy created by WOPR, most western Oregon BLM districts quietly met or nearly met their timber targets in 2008 by thinning in plantations (typically 40-70 year old Douglas fir tree farms). Our organizations support plantation thinning when treatments accelerate the development of older forest habitat and restoring fire suppressed stands when minimal or no new ecologically

damaging roads are required. According to the BLM's 2008 Annual Program Summary and Monitoring Reports, the Roseburg District sold 44.4 mmbf; the Eugene District sold 50.2 mmbf; the Salem District offered 55.3; and the Coos Bay District's numbers are not yet available but likely above its target. This is in sharp contract to the Medford District, which sold 27.8 mmbf in 2008 and a mere 5 mmbf in 2007. The Medford District's low volume numbers are a result of its choice to propose controversial mature and old growth logging that has been met with steadfast and successful litigation. Clearly, there is a forestry program that enjoys widespread support on western Oregon BLM districts and one that is enshrouded in controversy and legal gridlock.

To help you more fully understand the state of the BLM's timber program in western Oregon, we have attached a list of projects that will likely go unchallenged and a list of problematic projects. We hope this offers a better understanding of what will likely move forward through the National Environmental Policy Act process quickly and what will generate continued distrust and gridlock. We encourage you to give BLM district managers in Oregon clear direction to avoid planning projects in mature and old-growth forest habitat.

We look forward to working with the new Administration on projects that enhance endangered species habitat, will deliver logs to mills and can employ a robust workforce in our forests. We are willing stakeholders in creating a new forest management vision for our western Oregon BLM lands. Please do not hesitate to contact us with thoughts or ideas.
