The evening includes a plated dinner by Market of Choice catering, drinks, live and silent auctions, a live jazz group, and lots of holiday cheer. Thanks to generous community support, every dollar we raise at the event directly contributes to Cascadia Wildlands' work to protect and restore our incredible bioregion—Cascadia. **In 2018, revenue from the Wonderland Auction made up more than 1/5 of our annual operating budget** — a critically important event that ensures we achieve conservation victories!

RECENT VICTORIES:

1. Passed a bill in federal Congress designating the Devil's Staircase Wilderness and permanently protecting 30,000 acres of primeval old growth forest in Oregon's coast range.
2. Halted the Thurston Hills timber sale, a 100 acre clearcut proposal in a public land recreation area near Springfield.
3. Submitted 42,000 comments to the Oregon Department of Environmental Quality and earned a denial of a key permit needed to construct the Jordan Cove fracked gas pipeline.
4. Upheld protections from destructive mining in critical salmon habitat in Oregon.
5. Banned trapping of the imperiled Humboldt marten in Oregon.
6. Put a halt to the implementation of a bad wolf management plan and initiated a process of developing better protections for wolves in Oregon.
7. Saved thousands of acres of western Oregon public forests with strategic litigation and advocacy.





ONGOING MAJOR BATTLES:

1. Halt the proposed Jordan Cove fracked Gas Pipeline and taking concrete steps toward a climate stable future.
2. Challenge destructive post-fire “salvage” logging practices and protect natural post-fire forest regeneration.
3. Ensure lasting Endangered Species Act protections for the imperiled marbled murrelet and Humboldt marten.
4. Defend the Cascade-Siskiyou National Monument from losing its protected status.
5. Secure lasting protections for wild salmon from harmful suction-dredge mining in Washington.
6. Reinforce protections for gray wolves; stop continued state sponsored wolf kills in OR and WA.
7. Confront thousands of acres of reckless timber sales through close monitoring and litigation.
